#### 1. Overview of UZTEL S.A. Ploiesti during 06.09.2010-30.09.2015

#### 1.1 Establishment of UZTEL S.A. Company S.A. Ploiesti - Short history.

The company "UZTEL" S.A. Ploiesti was founded in 1904 with an experience of over 110 years in the main activity: design, production, repair, trading on the domestic and international market, oilfield subassemblies, assemblies, equipment and installations and manufacture of forgings and molded parts, spare parts for oil equipment, industrial machinery, repair of machine tools and others.

Since inception "Romanian - American Company" was designed for drilling, processing and distribution of petroleum products in Romania. The company was nationalized in 1948 and expanded its business by including repair of oilfield equipment.

In 1950 it was renamed "Plant Teleajen" and became an independent unit of the refining sector.

In 1958 the company was taken over by the Ministry of Oil and Chemistry and in 1963 became a part of the General Directorate for construction and Repair of Oil Equipment. After 1966 the company was subordinated to the Ministry of Petroleum.

The company was founded and registered with the Trade Register Office of Prahova County on 02.15.1991 at no. J29 / 48/1991, with the unique registration code RO 1352846 under the name SC UZTEL S.A. as a joint stock company, Romanian legal person with unlimited runtime in accordance with Law No.31 / 1990 - Companies Law.

Until 1990 it was called "Oil and Repair Equipment Company Teleajen" and

then, based on Law No.15 / 1990, Law no.31 / 1990 and GD no. 1213/1990 was reorganized as a business company and registered with the name SC UZTEL S.A.

In 2004 the company was privatized as a result of the sale-purchase contract no.77 / 2004 concluded between AVAS Bucharest as Seller and the Consortium Ploiesti consisting of UZTEL Association and Array Products CO LLC as Buyer.

#### 1.2 Shareholder structure

At present, consolidated synthetic structure on 30.06.2015 of the 3,872 inmates of financial instruments UZT symbol is the following:

- UZTEL Association Ploiesti 4,498,300 shares 83.8381% of the share capital;
- Individuals 330,758 shares 6.1646% of the share capital;

#### 1.3 Legal status of the Company S.A. UZTEL Ploiesti

By Conclusion pronounced on 06.09.2010, in case no. 4732/105/2010 Prahova Court - Commercial and Administrative Contentious Department - Bankruptcy office admitted the application of the debtor company UZTEL SA Ploiesti based in Ploiesti, str. Mihai Bravu. 243. Pursuant to Art. 32, para. (1) of Law no. 85/2006 on insolvency, County Court ordered the opening of insolvency proceedings Society general UZTEL SA Pursuant to Art. 34 of Law no. 85/2006 on insolvency , appointed as trustee EUROINSOL CONSULTING SPRL represented by associate coordinator Ploiesti av. Mariana Alina Maer.

By conclusion pronounced on 05.11.2010, in case no. 4732/105/2010 the Prahova County Court - Commercial and Administrative Contentious Department - Bankruptcy office, was ordered under Article 3 pt. 26 of the law on insolvency, removal of UZTEL SA Company's management rights.

which took place on 22.03.2011, adopting EGM Resolution no. 2 / 22.03.2011 approved the appointment as Special Administrator Radulescu N. Dan PFA, based seated in Bucharest, sector 1, 24, Strabuna Street, with the Trade Register number F40 / 4640/2010 and Unique registration code 27343132.

By conclusion pronounced in Council Room on 27.05.2011 in case no. 4732/105/2010 the Prahova County Court - Commercial and Administrative Contentious Department - Bankruptcy office noted the appointment of Special Administrator Radulescu N. Dan PFA which is responsible for representing the interests of shareholders under the provisions of Law No. 85 Article 18/2006 on insolvency without involvement in the management, in the conditions of the irrevocable removal of the right of management of the Company UZTEL SA Ploiesti.

By conclusion pronounced in Council Room on 30.06.2011 in case no. 4732/105/2010 the Prahova County Court - Commercial and Administrative Contentious Department - Bankruptcy office pronounced in the council chamber confirms the consortium consisting of Euro Insol SPRL, headquartered in Bucharest, 2, Baladei Street, bl.56, sc. 2, 4th floor, ap.66, sector 4 and Euroinsol SPRL Consulting, based in Ploiesti, 21, Bdul Republicii, bl. A5, ap.5, Prahova county to administer the UZTEL Society SA debtor the insolvency proceedings.

On 09/10/2012 Dolj County Court- Civil section II passed in case no. 4732/105/2010, the Sentence no.1282 by which, under article 101 of the Law. 85/2006 on the insolvency procedure, confirms the Reorganization Plan of the Company UZTEL SA Ploiesti, plan proposed by the debtor through special Administrator and thus ordered properly reorganization of the company's activity over a period of 3 years.

By the Decision no. 1 of 10.10.2013 of the Extraordinary General Meeting of Shareholders UZTEL SA with the required quorum and majority, required under article 115 of Law no. 31/1990 R and dispositions of head. IV, art. 11 of the Constitutive Act of UZTEL SA was revoked the mandate of the Special Administrator Radulescu N. Dan PFA and voted to appoint a new Special Administrator in the person of Mr. Eng. Zidaru Ion - General Director of the UZTEL SA. Following the application to mentions' registration no. 61793 / 23.10.2013, the Extraordinary General Meeting of Shareholders Decision No.1 / 10.10.2013, based on the resolution nr.19127 of 25.10.2013 was entered in the Trade Register on 25.10.2013, disposing registration of mentions on persons empowered and publication of the Official Gazette of Romania, Part IV.

On 28/01/2014 Dolj County Court - Civil Section II - in case no. 4732/105/210, passed the Judgment no. 112 which, under art. 95 para. (4) and art. 101 para. (5) of Law no. 85/2006 on the insolvency procedure, confirms the extension and amendment of the Uztel SA Ploiesti Company Reorganization Plan, amendment proposed by the debtor by Judicial Administrator and Special Administrator - Eng. Zidaru Ion.

#### 2. Company management structures and components

#### 2.1. Staff evolution and assessment

The main capital of the Company is the human capital, skilled labors force which, to be maintained, needs material incentives.

For this purpose, UZTEL S.A. invested annually from the opening of insolvency procedure (06.09.2010) till now, significant amounts of money for the monthly payment of wages and social contributions to pension funds and health insurance.

Thus, at the opening date of insolvency procedure, the average gross wage /

salary was of 1.909 lei / month, now reaching an average gross salary / employee of  $2.160 \, \text{lei}$  / month, an increase of 13.00% granted in annual installments (2011 - 2015) to maintain and stimulate employees. The policy applied by the company in human resources is the material incentive to existing employees (average employees no. 2010 = 611, average employees no. at  $30.09.2015 = 441 \, \text{persons}$ ) and increase their professional performance. These wage increases have meant significant disbursements, namely:

- funds net wages paid in the period 06.09.2010 09.30.2015 totaling 56,071,448 lei;
- Current payments made to the social insurance budget and special funds in the period 06.09.2010 -30.09.2015 totaling 37,900,936 lei;
- overdue payments made to the state social security budget (pension fund) for employees who have ceased employment with the company for retirement in the period 06.09.2010 30.09.2015 total amount of 1,231,677 lei.

The job descriptions will provide a 100% of staff work time in terms of quantity and quality and provision of a portfolio of orders / contracts to maintain the number of jobs subject to a breakeven in the current conjuncture of national and international oil market developments.

On the opening of proceedings, 06.09.2010, UZTEL SA Ploiesti had a total of 651 employees and on 30.09.2015, according to the organizational structure is as follows:



The objectives of performance assessment are:

- better understanding of employees, their problems;
- solve problems related to promotion, transfer and end of individual labor contract.

Assessment of staff performance is made on the following evaluation criteria: quality of work, efficiency in work (productivity, work rate, fulfilling workload set), knowledge and skills necessary to function / profession, professional accommodation, self-improvement, the spirit of initiative discipline, collective integration, teamwork and ethical behavior.

Individual performance assessment activity is regulated by the working procedure PL-6.2-02.rev.A and is prepared in accordance with the integrated management system, in compliance with the system procedure PS- MQ-6.2.2-01.rev .A.

#### 2.2. Administration and management of UZTEL S.A. Ploiesti

In case 4732/105/2010, the syndic judge by irrevocable conclusion of November 05 2010, found out the incidence of article 3 section 26 Law 85/2006 in that the debtor UZTEL SA was removed the right of management, shareholders being deprived of the rights recognized by procedure that would have been exercised by the trustee institution.

Subsequently to the manifestation of shareholders' intention to reorganize, OSA of January 13, 2011, following the Shareholders Meeting of 22 March 2011

was appointed special administrator PFA Dan Radulescu.

By conclusion dated May 27, 2011 the bankruptcy judge noted the appointment of the special administrator in the conditions of irrevocable removal of right of administration, irrevocable conclusion.

As shown by the minutes of the Meeting of Creditors No. 191 / 24.05.2011, as recommended by the Committee of Creditors of 16.05.2011 the appointment in question of the second trustee was voted to 70.9909%, respectively Euro Insol SPRL Bucharest and Euroinsol Consulting SPRL will manage UZTEL SA Ploiesti USTEL SA debtor insolvency procedure, in order to reorganize by continuing business to pay debts and reinsertion in the commercial circuit.

On 30.06.2011 by the conclusion of the meeting irrevocable by the non-recurrence was confirmed as trustee for the UZTEL SA the consortium consisting of EURO INSOL SPRL and EURO CONSULTING SPRL, in charge of management of all of the debtor's business.

On 12.07.2012 Meeting of Creditors voted reorganization plan proposed by the debtor by special administrator Radulescu N. Dan PFA keeping the right of administration in charge of judicial administrators an updating the reorganization plan in terms of fee decided in Meetings and Committees of Creditors, which is respectively 3% from amounts collected by the debtor company Uztel SA Ploiesti under insolvency procedure.

Minutes of the Meeting of Creditors of 12 July, 2012 was published in BPI 10 459 / 24.07.2013 and was not challenged.

Sentence 1282/2012 of Dolj County Court, final, enforceable confirms the Reorganization Plan of the debtor and based on the conclusions of the Creditors' Meeting of 12 July 2012 mentions keeping the management right in charge of Judicial Administration Consortium.

The appeal formulated was dismissed by decision no. 1339/2012 the Court of

Appeal Craiova, which indicates that the plan was voted maintaining the right of administration in charge of judicial administrators with the task of updating the plan in terms of fee decided by the meetings and committees of creditors.

Application for review of the decision 1339/2012 was rejected by decision 147/2013 of the Court of Appeal Craiova. By the conclusion of December 20, 2012 bankruptcy judge rejected the application of clarification order's device, the conclusion is irrevocable in dismissing the appeal.

In the Extraordinary General Meeting of Shareholders of October 10, 2013, the shareholders present and empowered, approved by a percentage of 84.0131% of total votes, the removal of the Special Administrator - Radulescu N. Dan PFA and the appointment of a new Special Administrator in person of Mr Zidaru Ion, who holds also the position of Director General of the UZTEL SA

The Sentence no.112 / 01.28.2014 final, passed by Dolj County Court, Civil Section II confirms amendment and extension of the Uztel SA Ploiesti Reorganization Plan under Article 95 para. (4) and article 101 par. (5) of Law no. 85/2006 on the insolvency procedure.

Company UZTEL SA Ploiesti during the implementation of the Reorganization Plan is managed by the Consortium of receivers consisting of Euro Insol SPRL Bucharest, coordinator practitioner Att. PhD Remus Borza Adrian and Euroinsol Consulting SPRL, associate coordinator Av. Maer Alina Mariana appointing the General Director.

For the period of the implementation of the Plan of Reorganization, the UZTEL SA Company's management aims to maintain and motivate skilled labor by granting a corresponding wage fund index on inflation and taking into account the minimum gross wage growth in the economy.

### 3. Analysis of economic and financial situation in the period 06.09.2010 - 09.30.2015

The time taken as reference for this analysis is represented by recent years, beginning with the opening of insolvency proceedings under the Law no.85 / 2006, namely: 31.12.2010, 31.12.2011, 31.12.2012, 31.12.2013, 31.12.2014 and 30.09.2015. This analysis was performed to obtain a full picture of the evolution of economic and financial situation of the UZTEL SA, namely to understand the situation from initiation of insolvency procedure to date and the prospects for completion of changes of implementation of the Reorganization Plan.

From the data above clearly result that in the period 31.12.2010-31.12.2014 the return on operating activity registered a relatively constant positive evolution, which led to increasing the performance of the company and thus increasing its financial results with favorable terms for completion of full payment and on due time of debts payment program incurred in the Reorganization Plan and of current fiscal, wage and commercial liabilities of the company. This economic indicator is the result of streamlining and optimizing the contracts sales department, scheduling production, service supply, logistics, management and tracking production on the production flow, the ratio estimated/realized to which were undertaken corrective measures to maintain the company in a balanced economic circuit and not least the favorable market conditions.

Return on operating activity and economic and financial situation of the company on 30.09.2015 registered a downtrend, negative, due to unfavorable domestic and international market conditions explained by the collapse of oil prices and stop of investments in oil and natural gas field, with immediate and alarming repercussions as decrease by about 50% of the annual sales of the company.

The conclusions of the economic- financial analysis of the company operation since the opening of the proceedings so far are:

• The Company recorded profit from operations in 2011, 2012, 2013 and 2014, which means a good financial condition with positive effects for purpose, reason and target of the legal reorganization which are, on the one hand, maximizing wealth of debtor and, on the other hand, protecting the interests of creditors and satisfaction of claims in their entirety.







### 4. Sources of financing and strategy implemented to fulfill the objective of change of Reorganization Plan of UZTEL S.A. Ploiesti

Considering the current situation of the UZTEL SA and the evolution of markets in which the company operates, the Consortium of receivers - EURO INSOL SPRL and EUROINSOL CONSULTING SPRL and Special Administrator consider as appropriate the modification of the schedule of payment of claims relating to the Reorganization Plan, as required by law.

The elaboration of the proposal to amend the Company's reorganization plan is a consequence of the Special Administrator's initiative with the support of the Consortium of receivers in order to present the parties involved in the process (creditors, the bankruptcy judge, etc.) a statement of fact and law - economic, social and financial up to date of the Company in reorganization proceedings.

The reorganization plan of SC UZTEL S.A. was confirmed by the bankruptcy judge by sentence no. 1282 / 10.09.2012 of the Dolj County Court, in case no. 4732/105/2010, final and irrevocable by Decision Nr.1339 / 12.18.2012 of the Court of Appeal Craiova.

On 28/01/2014 Dolj County Court – Civil Section II passed in case no. 4732/105/2010, Sentence no. 112 which, under article 101 paragraphs in. (5) of Law no. 85/2006 on the insolvency procedure, confirms the change of the Reorganization Plan of Uztel S.A. Ploiesti and under art. 95 para. (4) confirms its extension for a period of 12 months, the changes proposed by the debtor by Judicial Administrator and Special Administrator.

As stated in the reorganization plan, although the assumptions taken into account at the time of the proposal were viable (as demonstrated by making full

payments for the first three (3) years of reorganization schedule of payments assumed in the plan), there may be situations beyond the control of the Company, which may change the initial conditions.

The provisions of art. 95 para. (1) of Law no. 85/2006 stipulate that the reorganization plan will indicate the possibility of recovery of the debtor's insolvency in relation to a number of elements considered by law as essential, namely:

- debtor's specific activity;
- the financial means available;
- debtor's offer market demand.

Given the dynamics of economics, possible variations in the market in which the debtor acts and that the reorganization may be spread over a relatively long period of time namely 4 years, the legislator has created the possibility of changing the plan when changes occur of items considered by law as essential or when the economic and financial forecasts envisaged at the time the plan are not consistent with how evolve the borrower activity and the market on which it works. Also, these essential elements in reorganization are interrelated such as changing one draws by default and amend other.

Change of payment of claims relating to the UZTEL SA reorganization plan in relation with debtor's evolution emerges as mandatory.

The economic and social effects of reorganization are obvious, considering the need to maintain within the economic circuit a company that has a good reputation in the domestic and international markets, owner of engineering and know-how certified by international certificates, materialized in obtaining important turnovers, and a good and important contributor to the consolidated state budget.

- full payment in the fourth quarter of the fourth year of unsecured debts except amounts related to unsecured creditors holding the status of associate members of the Association Uztel (majority shareholder Uztel SA Ploiesti) and which the company has entered and will enter after the publication of the amendment Reorganization Plan the debt rescheduling agreements of their debts after closing the insolvency procedure;
- full and timely payment of Company's staff salaries, the remuneration of external collaborators, including remuneration consortium of Receivers and of the Special Administrator;

# 5. Economic and financial arguments for fulfillment of changing the Reorganization Plan

"dead" company unworkable (patrimony which unused, undergoes degradation inevitable and destruction until the time of alienation). In the event of liquidation:
